

## **GET READY TO CHILL IN NEW ZEALAND CONTEST**

### **OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING. NO ALCOHOLIC BEVERAGES ARE INCLUDED IN ANY PRIZE.**

- 1. CONTEST TIMING:** The Contest begins at 12:00 PM Eastern Time ("ET") on July 1, 2019 and ends at 11:59:59 PM ET on August 31, 2019 ("Contest Period"). The Administrator's computer is the Contest's official clock.
- 2. ELIGIBILITY:** The Contest is open only to legal residents of the fifty (50) United States (excluding Utah) and the District of Columbia who are at least twenty-one (21) years old at the time of participation. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Contest Entities") and each of their immediate family members (e.g., spouse, parent, sibling, child, and their respective spouses and the "steps" of each, all lineal descendants, including those by adoption, regardless of where they reside) and persons living in the same household of each, whether or not related, state alcoholic beverage manufacturers, distributors, and retailers and employees of state or local alcohol beverage agencies are not eligible to participate or win. Void in Utah, Puerto Rico, all other United States territories and possessions, and where prohibited or restricted by law. All federal, state, and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions and interpretations, which are final and binding in all matters related to the Contest. All entries become the sole and exclusive property of the Sponsor and receipt of entries will not be acknowledged or returned.

- 3. HOW TO ENTER THE CONTEST:** During the Contest Period, an entrant may visit <https://chill.matua.co.nz> ("Website"), submit his/her email address, and complete the registration form, which may include, but is not limited to, complete first and last name (no initials), street address (no P.O. box), city, state, ZIP Code, telephone number, date of birth, and confirmation that the entrant has read and agrees to be bound by these Official Rules. An entrant may then follow the instructions to upload a photo that shows how the entrant "chills out with Matua" along with a title and description.

The photo must be in .JPEG, .JPG, .PNG, or .GIF format and may not exceed 8 MB. **Photo may or may not include a Matua Wine bottle (including Matua Wine in the photo is optional and will not improve your chances of winning).** By submitting an entry, an entrant hereby grants permission for the entry to be publicly posted at the Website, Sponsor's social media accounts, or other website, at Sponsor's sole discretion. Once an entry is submitted, as described above, it may be made available on the Website, Sponsor's social media accounts, or other websites for viewing by the general public and any such posting will be deemed made at the direction of the entrant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act.

During the Contest Period, an entrant may also text CHILL ("Keyword") to 87654 ("Short Code") to obtain a link to the Website. **Note that an entrant cannot participate in the Contest solely by texting the Keyword to the Short Code. Message and data rates may apply for each text message sent or received.** Not all mobile telephone providers carry the service necessary to access the Website. Entrants should consult their wireless providers' pricing plans. An entrant may, at any time, choose to stop participating in this Sweepstakes by sending an opt-out text message stating "STOP CHILL" to the Short Code. If an entrant sends an opt-out text message, he/she will be sent a reply text message, which will confirm that he/she has been unsubscribed and will receive no further text messages. - Must not contain material that is inappropriate, indecent, lewd, pornographic, obscene, hateful, tortious, defamatory, slanderous, or libelous (as determined by Sponsor at Sponsor's sole discretion);
- Must not contain, facilitate, reference, or use material that promotes bigotry, racism, hatred, or harm against any group or individual or promotes discrimination based on race, gender, ethnicity, religion, nationality, disability, sexual orientation, political orientation, citizenship, ancestry, marital status, or age (as determined by Sponsor at Sponsor's sole discretion);
- Must not contain any viruses, spyware, malware, or other malicious components that are designed to harm the functionality of a computer in any way;
- Must not contain material that is unlawful, in violation of, or contrary to the laws or regulations in any jurisdiction where posted;
- Must not contain, show, mention, refer, or allude to any inappropriate use of Matua Wine; and
- Individual(s) pictured must be twenty-one (21) years of age or older.

**NOTE:** If any entry fails to comply with any of these requirements or any other provisions of these Official Rules, Sponsor reserves the right to disqualify the entrant, at its sole discretion.

**IMPORTANT NOTE:** Any entrant who incorporates any intellectual property owned by a third party into his/her entry does so at his/her own risk. Without in any way limiting, expanding, or amending the terms and conditions residing on the Website, which terms and conditions shall remain in full force and effect, if Sponsor is duly notified that any element of an entrant's entry infringes upon the rights of another person and/or receives a legally valid request to remove the affected entry from the Website because of such infringement, such entry may be disqualified from the Contest, as Sponsor may determine in its sole discretion. Further, no entrant will be eligible to receive the prize unless Sponsor determines, in its sole and absolute discretion, that such entrant's entry has been or can be sufficiently cleared for legal purposes and such entrant's eligibility is verified. **Entry Limit:** An entrant may submit no more than one (1) entry per day during the Contest Period. A "day" is defined as starting at 12:00 AM ET and ending at 11:59:59 PM ET on a calendar day during the Contest Period, except on July 1, 2019, when a day is defined as starting at 12:00 PM ET and ending at 11:59:59 PM ET. An entrant who attempts to enter more than the stated limit may be subject to disqualification from the Contest.

- 4. CONTEST JUDGING AND WINNER SELECTION:** Following the Contest Period, all valid entries will be judged by a panel of qualified judges ("Judges"). The Judges will score entries according to the following weighted criteria: (i) Personality (fun): 34%; (ii) Creativity: 33%; and (iii) Originality: 33% ("Judging Criteria"). The one (1) highest scoring entry will be considered the potential winner, pending verification of eligibility and compliance with these Official Rules. In no event will there be more than one (1) potential winner. In the event of any ties, the entry with the highest score in criterion (i) will prevail. In the event there are still any ties, the tied entries will be re-judged and the entry with the highest overall score will prevail.
- 5. PRIZE (1):** The prize is a seven (7)-day/six (6)-night trip for the winner and one (1) adult guest to visit the Matua Vineyards in New Zealand ("Prize"). Trip include round-trip coach class air transportation from a major commercial airport near winner's residence to Auckland, New Zealand for winner and one (1) adult guest; round-trip coach class air transportation from Auckland, New Zealand to Blenheim, New Zealand for winner and one (1) adult guest; six (6) nights total hotel standard accommodations (two [2] nights each in Auckland, Marlborough, and Bay of Many Coves; single room/double occupancy); lunch or dinner and soft drinks with Bill Spence in Auckland; winery tour with Chris Darling in Marlborough; and three (3)-course dinner and soft drinks, full breakfast, boat transfer to and from hotel, and Eco Tour in Bay of Many Coves. Prize includes dinners and soft drinks, but does not include alcoholic beverages. Wine or any other form of alcohol will need to be purchased separately by the winner. Winner's guest must be twenty-one (21) years of age or older. If the winner elects to travel or partake in the Prize without a guest, no additional compensation will be awarded to the winner. Trip must be taken on dates specified by Sponsor and must be taken by February 29, 2020 (subject to Sponsor's discretion). Winner and guest must travel on the same itinerary. The actual value of the trip may vary depending on point of departure and fluctuations in the cost of air transportation. Any difference between the estimated approximate retail value ("ARV") and the actual value of the Prize will not be awarded. Travel dates are subject to availability; blackout dates and other restrictions may apply. Winner and guest are responsible for having valid travel documents including government identification and/or passports. Winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs

Guest of winner must sign and return a travel liability release before travel will be booked. Winner and guest hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of the trip. Any damage to the room will be the responsibility of the winner. Sponsor bears no responsibility if any event, element, or detail of the Prize is canceled, postponed, or becomes unavailable for any reason. Should any event, element, or detail of the Prize become unavailable, Sponsor shall have no obligation to the winner aside from providing the remaining portion of the Prize, minus any unavailable event, element, or detail. The ARV of the Prize is \$10,050. One (1) Prize will be awarded.

Before being declared the winner, the potential winner will be required to execute an Affidavit of Eligibility/Liability & Publicity Release and tax acknowledgment ("Affidavit") sent with the email notification. The potential winner must return a fully executed and notarized Affidavit to the Sponsor or its authorized designee within ten (10) calendar days from the date it is dated as being sent to the potential winner. Contest and/or accepting the Prize; and (viii) entries that are late, forged, lost, misplaced, misdirected, tampered with, incomplete, deleted, damaged, garbled or otherwise not in compliance with the Official Rules. THE JAMS RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN CALIFORNIA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN NAPA COUNTY, CALIFORNIA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR CONTEST ENTITIES AND/OR ANY**
